



And a quiet sleep and a sweet dream when the long trick's over.



Thanks everyone I am sure we are all looking forward to 2021.



EDUCATIONAL OFFICER

P/D/C Ted Reiss, SN-CN

Ready to keep learning? I am. On January 13th I will be installed as the Squadron Educational Officer replacing Tippy Cavanagh, our most dedicated instructor, Past SEO and Past Commander. She continued to make the America's Boating Club – Marco Island one of the best in District 22 and the nation, especially over these trying times.

Our classroom was recently cleaned and reorganized. For the present Advanced Piloting course we start with a temperature check, wear masks, use a hand sanitizer and after class I wipe down the tables and chairs etc. with a Clorox disinfectant. John Salotto has donated an air purifier to further clean the air.

For the coming year I have identified several courses and seminars potentially of interest to our members. Starting with at least one America's Boating Course open to both members and non-members, our classroom can handle seven people/couples each at different tables to keep the six foot separation.

The first advanced grade course is Boat Handling comprised of six seminars. You can take the whole course or any of the individual seminars. Seminars are: Rules of the Road: A Practical Approach; Confidence in Docking and Undocking; Slow-Speed Maneuvering; Boating with Confidence: Handling Your Boat Underway; Anchoring with Assurance: Don't Get Carried Away; Emergencies on Board: Preparation to Handle Common Problems; and Knots and Line Handling: The Knots You Need to Know. This is a great course for the 50% of our membership that have not yet taken a course.

Other courses being considered are: Piloting, Advanced Piloting and Junior Navigation. Seminars are: Instructor Development, Operations Training, Partner-in-Command, Charting/GPS and On-The-Water Training.

At this point in time our classroom can accommodate seven individuals or seven couples. We follow the CDC guidelines. So first come, first registered.

Please let me know what courses or seminars you would like to attend so we can set up dates and instructors. Your response by 10 January is appreciated. Also let me know of other course, seminars or topics you have an interest in.

Hope to hear from you. See you at the Learning Center.

Marine Safety Alert

The U.S. Coast Guard's Office of Auxiliary & Boating Safety (CG-BSX) has issued a new Marine Safety Information Bulletin (MSIB 20-20) related to performing a VHF Marine Radio Check. The MSIB was issued in response to the discontinuation of the Sea Tow-operated Automated Radio Check System, which was available on VHF Channels 24 to 28 for the benefit of mariners in over 130 locations. The service was discontinued during October.



Before leaving the dock, do you perform a radio check on your VHF? Remember, if you have a radio, the Coast Guard requires it be turned on to channel 16. If you have a cellphone, is it charged?

How to test a VHF Radio using Rescue 21: The U.S. Coast Guard continues to offer an automated Digital Selective Calling (DSC) Test Call capability from each of its Rescue 21 coastal stations. All fixed mount marine radios certified by the Federal Communications Commission since 1999 are required to have a DSC capability. All such radios sold since 2011 must also have a DSC test call capability. Marine radios transmitting and successfully receiving a response from a DSC test call can be expected to operate acceptably in the voice mode as well.

To perform a DSC Test Call, enter the U.S. Coast Guard's coast station group identity "003669999" into the radio's DSC memory. Once entered and stored, a DSC test call can be made by executing the following three steps:

- 1) Select "Test Call" from the radio's DSC menu,
- 2) Select the USCG number entered into memory, and
- 3) Transmit the call.

The radio display should indicate when that test call is acknowledged and display the acknowledging station's nine-digit identity. That identity may be different than the group identity previously entered into memory.

Please use VHF Channel 09 and do not use VHF Channel 16:

VHF Channel 16 is not for the purpose of radio checks.

Please use VHF Channel 09, which has been designated by the FCC as a boater's calling channel.

 - Keep nautical charts accurate
- Activities
 - Periodically survey ATONs from Everglade City to a mile north of Marco Island
 - Report discrepancies to responsible agencies (City, County, USCG)
 - Publish survey results on marcoboatingclub.org



Summary

Marco Island ATONs

- City of Marco Island responsible for 52 ATONs
 - 15 need repair
 - 1 Poor condition
 - 4 Missing completely (1 may not be needed)
 - 10 Piling only (7 may not be needed)
 - 13 are off-station >150 ft. compared to USCG Light List
 - 10 of these are on chart 11430
 - Correction requires USCG action (none is in sight)


