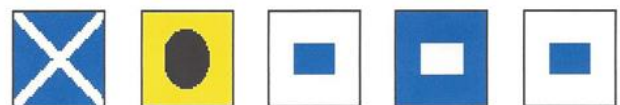

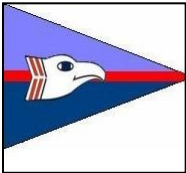

The 2025 Wine & Hors d' Oeuvres Fundraiser is upon us (Friday, January 31st at the San Marco Church Parish Hall – 5PM). In October, the MISPS Bridge and Marketing Committee went into full planning mode.

To deliver a **Wine & Hors d' Oeuvres Fundraiser** we can all be proud of, it will require our members to bring “all hands-on deck”!

In the next two months we will be asking you to help us by:

- **Buying your Tickets to the event** – 2 tickets for you & your family, and ask you buy a third ticket for a neighbor, friend, or please sell to an acquaintance. Tickets this year will be \$40 (a \$5 increase from 2024, since our costs have gone up by 30%).

- **Help us deliver the Wine & Hors d' Oeuvres Event itself!** You can help sell 50/50, Raffle Tickets, greet and process attendees at the door, decorate the hall ahead of the event, be part of the

Kitchen staff, man the silent auction tables, or be in the post-event clean-up crew all fun, eh? I, myself, have a specialty in busing tables!

As you can imagine, putting on the **2025 Wine & Hors d' Oeuvres Fundraiser** event for 300 people requires much preparation, many busy hands, and maintaining a spirit of fun and laughter. This fundraiser is our only fundraiser of the year, and it helps fund our Education Department and pays for tax, maintenance and insurance for our MISPS Club Condo.

The second subject I want to share with you this month is: How **FWC (Florida Fish & Wildlife Conservation Commission)** is addressing **hundreds of vessels displaced by Hurricanes Helene and Milton.** Hurricanes Helene and Milton displaced hundreds of vessels on the Florida west coast, including our SWFL vicinity, due to high wind and storm surges. Many vessels were swept onshore, others were damaged in marinas and private docks, others relocated but still afloat, and some partially or fully sunken.

The FWC has deployed derelict vessel specialists to southwest Florida to locate, identify and investigate vessels rendered derelict due to the storms. The public can report vessels displaced **on state waters** by calling **888-404-3922**. Be prepared to provide vessel location and description (if known provide registration number).

- Vessel owners are encouraged to hire a salvage company to recover their vessel
- Owners of displaced vessels who lack the resources to have their boat repaired, or if their vessel is determined to be beyond repair, may release ownership of their vessel through a waiver provided by the FWC.
- Owners have 45 days to either remove their vessel from the State waters or bring it into a non-derelict condition.

Boat owners need to know they have options regarding their vessel's future – call the FWC Boating and Waterways Section at **850-488-5600**. This FWC program includes **waterway debris** that is not a vessel, oil spills, chemical releases, fuel or hazardous materials spills in Florida waters – call 850-366-6007 or visit FloridaDebrisCleanup.com.

For those of us who experienced no damage with the recent hurricanes, we thank the lord. Perhaps having

the above information, you may help someone else avail themselves of critical resources.

EDUCATIONAL OFFICER
P/D/C Ted Reiss, SN-CN



Fall education program started on October 14 with the ABC class of 3 students. Hurricane Milton caused a disruption of dates and student availability.

The Boat Handling course started on 28 October with 5 students.

Our squadron received the District 22 award for the Prince Henry the Navigator trophy related to having members pass from Advanced Pilot to Junior Navigator. Instructor P/C Tippy Cavanagh SN and her students are commended for this achievement.

National education department is creating a number of seminars we can use. Seminars are generally about two hours long, but most are shorter. They have a very low cost. There is no test at the end. Each seminar has one topic directly related to its name. We can get the slides for presentation and handout material that can be further tailored to our member's interest.

About 60 of our squadron members have boats and have some level of understanding about many aspects of safe boating and experience.



We need instructors to present the information. Without instructors we cannot offer the seminar information. Instructors need not be certified, although we can get you USPS certified. If you have any interest in sharing some facet of your experience, please, please let Jeff Williams or myself know how we can get you involved. We are a volunteer organization committed to contributing to the whole group. I deliberately did not include the topics of the potential seminars. Let me know your interest, even if we need to modify or combine prepackaged material. It all starts with you taking an interest.

So, go boating, be safe and keep learning.

CALL 911

In my first aid classes and the situational awareness “How to be safer” presentations, I continually stress the need to promptly call the Collier County Sheriff’s Office Communications Center, what we refer to as 911. I also talk about in a safety threat or if a medical emergency arises, the need to “build your team”. We should never hesitate to call 911 if we feel there is a medical emergency or a suspicious incident occurring. The biggest problem in many cases is that a call to 911 for help was delayed.

So, using a cardiac arrest as an example, the **FIRST** thing you do is call 911 and then start chest compressions. What exactly happens when you make that 911 call and what should you tell the 911 operator? First, you need to understand the EMS emergency and non-emergency system. All calls made to both 911 and the non-emergency calls to 239-252-9300 go to the same place. The public safety center is located on Lely Cultural Parkway off Collier Blvd (SR951). That dispatch center also handles dispatching all calls going out to the Sheriff’s Office, Naples police department, Marco Island police department, EMS and all the fire departments in the county. This coordination and centralization make for a very efficient system.

So, what does happen when you call 911? To answer that question, like always, I like to go to the experts.

I reached out to Capt. Chris Gonzalez who oversees the Collier County Sheriff's Office Communications Center, and his communications manager Amy Tuff and asked just that.

What should someone tell the 911 operator when they call about a medical emergency of any kind?

The most important information that the caller can provide is their location. We want to verify that the emergency is at the location they are calling from, and if not, be able to quickly obtain the location to the emergency so that we can create a call for service.

What can the caller expect to hear? What specific things will the 911 operator be asking and telling the caller?

Our dispatchers are certified, trained, and follow a medical protocol system that allows us to provide the callers with lifesaving medical instructions until the first responders can arrive. In situations where a patient is experiencing cardiac arrest, the dispatcher will first ask the caller if an automated external defibrillator (AED) is available and if so, to send someone to retrieve it. After that, depending on the situation we will monitor the patient's breathing or begin instructing the caller on how to provide CPR.



Can you describe what the communications center does? For example do all calls for fire, police and Ems go through the same center, room and persons? Do you do tours?

Our center dispatches for the Collier County Sheriff's Office, Marco Island Police Department, Collier County EMS, and the five fire districts. All 911 calls within the county limits are routed into our center. Then our dispatchers obtain information from the caller that dictates which responding agencies are sent to the call.

We give tours on a regular basis and host open house events for both recruitment and educational purposes. We welcome the community to come and visit our center and learn about the county's emergency operations.

Another thing I discuss in my first aid classes is a

phone App called Pulse Point. Pulse Point follows the calls going out from whomever your local law enforcement agency is, in our case the Collier County Sheriff's Office. When you open Pulse Point, it will show you on a list and a map where calls for service are occurring. Activate the AEDs on the map layers and this App will show you every AED in your area. This is one of the huge plusses of our emergency dispatch system. There are AEDs located all over our county and the 911 dispatcher will tell you exactly where to have someone run in and get that AED out to your medical emergency. You also, when trained on CPR, can activate an alert where Pulse Point will alert you if CPR is needed near your location. I asked Capt. Gonzalez about Pulse Point.

The Pulse Point application is an incredible tool that allows CPR certified individuals to be notified of emergencies requiring CPR near them. This alert provides the location of the nearest AED and allows the user to provide lifesaving measures until our first responders can arrive.

I asked Communications manager Amy Tuff if there was anything else going on with the communications center and she added.

We are embarking on our fourth year in a partnership between the Collier County Sheriff's Office and Immokalee Foundation. This is an instrumental program where students are trained on the state of Florida's 911 public safety telecommunicator curriculum with hopes of becoming state certified and ultimately offered a position to work for the sheriff's office. Recently, one of our students from the first graduating class received a Phoenix Award for providing CPR instructions to a caller. The Sheriff's vision to empower and educate our youth on the exciting

opportunities they can embark on upon graduation has been truly instrumental in establishing long term careers for these students.

So, the takeaway for this month is never hesitate to call 911 if you believe a medical emergency or suspicious incident or crime is in progress. Take that CPR/AED First Aid class and get Pulse Point downloaded to your phone. Getting training and being situationally aware can save a life!

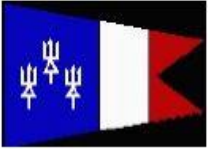

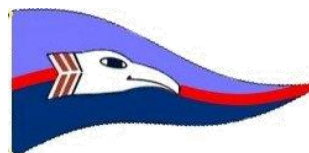
